We want to make sure your prized possessions receive the best care during your relocation with our firm. To help us make sure things go well (and to satisfy an interstate commerce commission requirement), would you please declare:

- [A]** Items with a value of \$100 per pound or more.
- [B]** A single item or matching sets of items with a value of \$2,000 or more.
- [C]** Firearms tendered for transportation must have Make, Model & Serial Number.

Packable items of an extraordinary value and Firearms must be packed by carrier for control, receipt, and liability. **(In accordance with Federal Regulations, failure to disclose such articles will result in limited carrier liability).** Shippers are required to have these items unpacked and acknowledge receipt at the time of delivery.

Owner / authorized representative agrees that any claim for loss or damage must be supported by proof of value and understands the settlement for items of extra-ordinary value will be based on the information furnished, subject to a maximum amount declared above, or the lump sum value declared on the Uniform Household Goods Bill of Lading and Freight Bill, or repairs or replacement, whichever results in the lower cost.

**IMPORTANT**

- If, for any reason, you have not listed items of extraordinary value with a value to \$100 per pound or more, any liability of the carrier shall be limited to no more than \$100 per pound per article based on the item's actual weight, limited to a maximum amount declared on the Uniform Household Goods Bill of Lading and Freight Bill.
- Single items or matching sets of items with a value to \$2,000 or more must be listed on this form. Failure to list such items will limit carriers liability to a maximum of \$1,000 on an unlisted item, or matching sets.
- If there are no items being shipped with a value of \$100 per pound per article or single or matching sets of items with a value of \$2,000 or more the word "NONE" shall be entered in the declaration portion above.

The requirement to declare items of extraordinary value was promulgated by the Interstate Commerce Commission, and designed to protect customers as well as making the carrier aware of the value of the items being relocated.

The driver will be provided the Items of Extraordinary Value / Single items or Matching sets of items for inventory and delivery. Any Items of extraordinary value packed at origin must be unpacked by the driver at the time of delivery in your presence, and acknowledgment of receipt signed for below.

By the signature below, shipper agrees this is a true and complete list of all items tendered for transportation of an extraordinary value.
